TARIFF UPDATE

The following items were updated in the Sun Valley General Improvement District Tariff (for full Tariff details, visit <https://www.svgid.com/customer-info/rules-and-regulations/>):

- District Rule No. 5 includes language regarding disputed credit/debit card payments.
- District Rule No. 12 outlines increases of deposits for water customers and sewer services customers only.
- District Rule No. 15 increases the inspection fee for Non-Residential Backflow Prevention Devices.
- District Rule No. 21 increases the After-Hours Emergency Services Fee, discontinue after hour installs for new service and a fee for refunds to General Water Facilities Charge Payment Options.
- District Rule No. 22 increases the After-Hours Emergency Services Fee, discontinue after hour installs for new service and a fee for refunds to General Sewer Facilities Charge Payment Options.
- District Rule No. 23 increases Construction Inspections Fee, Facility Damage Fees, Customer Lock Fee and Damaged Facilities.

NATIONAL RADON DETECTION MONTH

Radon is a silent killer not often talked about. It is estimated that nearly 21,000 people in the US die each year from lung cancer caused by indoor radon exposure.
